Plan Summary [2021-22]

General Information

A description of the LEA, its schools, and its students.

Yosemite-Wawona Elementary Charter School (YWECS) is a small TK - 6 multiage school located near the southern boundary of Yosemite National Park. There are 17 students enrolled in the Montessori-based school. The Montessori approach works exceptionally well in a multi-graded classroom as students are encouraged to learn through various activities that challenge their intellect at their appropriate pace. The adults in the school serve as guides to enhance a child's learning ability by appealing to their creativity and engaging in hands-on activities that teach math, language, cultural and practical life lessons. Students enrolled at the school come from the Wawona area and from surrounding communities. Demographically, the school's enrollment is mostly White (80% white and 20% 2 or more races) and includes an unduplicated count of 33.33%. There are no English Learners and no Foster students enrolled. Approximately 17% of the students are special needs students. Being located in Yosemite National Park affords the school many opportunities to experience the various wonders of the Park, making enrichment activities easy to schedule and provide. In the past (before the pandemic) Park Rangers taught students about nature, fire ecology and the Park system as well as the very interesting history of the Wawona area which students can experience first hand. It is hoped that this service can be reinstated as the pandemic has eased somewhat. The safe and comforting family atmosphere developed by the staff has helped students weather the disruptions that have occurred over the past year. YWECS is a unique school that provides a unique educational experience for its students.

Reflections: Successes

While the school is too small to have any data posted on the California Dashboard, individual and group progress is monitored throughout the school year through the use of Individual Learning Plans that have been established for each student. The school was granted a waiver for in-person instruction in October that allowed it to open with a hybrid model of education. Students were grouped into 2 pods of 8 and were at the school for in-person instruction 2 days per week. The distance learning and hybrid approaches employed through March were certainly an

impediment to student learning. Once students returned full time for instruction in March, staff was better able to identify student progress and provide the support that students needed after an extremely disruptive year. Generally, learning loss was widespread, but having all students return to face to face instruction on March 1 was a great benefit academically and socio-emotionally.

Reflections: Identified Need

The size of the school precludes Dashboard data being available. However, student progress is monitored closely throughout the year through the development of an Individual Learning Plan for each student. These plans are developed by the teacher, the parent and the student through a scheduled meeting early in the year. On a weekly basis, the teacher assesses student progress towards these goals and then makes adjustments to the plan as necessary. The teacher, parent and student meet together 2 additional times during the year to keep apprised of the progress on the Individual Learning Plan. Staff has identified improving social/emotional development as a goal for the coming year. Due to the psychological effects of the pandemic on students and their families, the continued development of the supportive family atmosphere at the school is a high priority. Additionally, the further development of mathematical skills in students is an area that needs attention.

LCAP Highlights

YWECS will continue to offer a unique educational experience to its students. This includes the continuation of the Individual Learning Plans and the Montessori learning approach that works so well in the multiage classroom environment. The goal setting activities for each student scheduled at the beginning of the year and then monitored through meetings of the students, parents and teacher throughout the year keep student progress at the forefront and allow students to practice the important lifeskill of setting personal goals. Enrichment activities that take advantage of the setting of the school should be much easier to schedule as the restrictions of the pandemic are lifted. As most of the students are returning students, the staff is anticipating a quick return to the routines and functions that make the school so effective. Coming back in March for the 2020-21 year assisted in this transition back to normal school life. Survey results demonstrate that students and parents are happy with the direction and accomplishments of the school.

The development of the LCAP for 2021-22 has been an information item for the Board of Directors for many months. The majority of the Board is made up of parents of students at the school - in fact half of the students enrolled have a parent who serves as a Board member. Stakeholders were surveyed about conditions for learning at the school. A survey of parents was distributed and returned. 100% of parents responded. There was overwhelming support for the academic individualization of students and for the support they receive from the staff. Parents also felt strongly that the staff cares about their child(ren)s' well-being, that they as parents feel welcome at the school and that they felt that the school worked well with them as partners in the educational process. Students were also surveyed. They indicated that they feel safe at school, that they do interesting activities and that the adults at the school listen to them and care about them.

A summary of the feedback provided by specific stakeholder groups.

The parent surveys indicated a high level of support for the school. High marks were awarded for home/school communication, a caring and compassionate attitude towards students, the partnership forged between parents and the school and the academic individualization approach that is the base of all learning programs. Student surveys indicated that they feel safe at school, that they do interesting activities and that the adults at the school listen to them and care about them. They were unanimous in stating that they are happy at the school.

Stakeholder feedback indicated that the school needs to stay the course in terms of its individualized approach. Parents and students alike appreciate this path to learning. The Individual Learning Plans have been effective in spurring student growth. Staff indicated an interest in CAASPP results for the current school year to be used as an additional barometer of student success. As the school was closed in 2018-19 and then no state testing was conducted in 2019-20, it has been quite a while since this type of measurement has been conducted. These results will help guide additional steps to be taken in the coming year.

Introduction and Instructions

The Local Control Funding Formula (LCFF) requires LEAs to engage their local stakeholders in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have ten state priorities). In order to address this condition of our low-income students, we will develop and implement a new attendance program that is designed to address some of the major causes of absenteeism, including lack of reliable transportation and food, as well as a school

climate that does not emphasize the importance of attendance. Goal N, Actions X, Y, and Z provide additional transportation and nutritional resources as well as a districtwide educational campaign on the benefits of high attendance rates. (Contributing Action(s))

These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100% attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
